- Each NE, bio, or stepping on a leg, cone, plant or any component of the obstacle
- Incur or break of gait at walk or trot for two strides or less
- Both front or hind feet in a single stride space at a walk or trot
- Stepping over or falling to step into required space
- Incur more than 2 strikes, if specified
- One to two trips on dismount or ground fee except shifting to balance
- Roll over at lope
- Over-shoulder (per maneuver)
- Out of frame (per maneuver)
- Wrong lead or out of seat for less than 2 strides

- 3 Point Penalties:**
- Wrong lead or out of seat for more than 2 strides
 - Dropped reins
 - Break of gait at Lope
 - Break of gait at Walk or Trot for more than two (2) strides
 - 3-4 trips on dismount or ground fee
 - 7-tripping more than 3 strides in a lope departure or exiting a rollback into a lope

- Hocking down or over, or severely disturbing an obstacle
- Stepping out of or falling off of an obstacle with one foot
- Missing or evading part of a log/obstacle that is part of a series of obstacles with one foot

6 Point Penalties:

- Spurring in front of cinch
- Blatant disobedience
- Use of either hand to assist lead/brake
- Knocking over, stepping out of, or falling off of an obstacle with more than one foot
- Dropping an object required to be carried
- 1st or 2nd cumulative refusal
- Letting go of gait
- 5 or more steps on dismount or ground fee
- Missing or evading part of a log/obstacle that is part of a series of an obstacle with more than one foot

- Breaking pattern
- Repeated blatant disobedience
- Use of two hands (except in snaffle bit or hackamores)
- More than one finger between split reins or any fingers between normal reins (except two index)

DQ:

- Lameness
- Abuse
- Illegal equipment
- Disrespect or misconduct
- Leaving arena before pattern is complete
- Imperson western attire
- Fail of horse/rider
