Error / Penalty 3b
 • Tick of leg, pole, cone, plank or obstacle

Error / Penalty 3
 • Hit or step on • Incorrect or break of gait at walk or jog / 2 strides or less
 • Both feet in space • Step space • Split pole
 • Failure to meet correct strides

Error / Penalty 3
 Incorrect or break of gait at walk or jog over 2 strides • Cut of lead or break of gait at legs • Knockdown • Step out or jump off with one foot (After entering)

Error / Penalty 3
 • Step Out or jump off with two or more feet (After entering) • Drop object • 1st refusal or evade • Dropping Gaze • Blanket disobedience • 2nd refusal or evade
 • Intill feet or prance • Lidding saddle horn

Error / Penalty 0
 • Steer obstacle wrong • Wrong line of travel • Hitting obstacle wrong boundary • 1st refusal or evade
 • Dropping the rope and not picking it up • Fail to complete obstacle • Hesitancy or repeatedly touching horse • Overturn of more than 1/2 turn
 No attempt to perform obstacle • Performing obstacles out of order • In-hand: Horse gets loose or leading on the wrong side
