 Class: Rasseoffen Walk-Trot Ranch Trail

- Each leg, bit, or stepping on a leg, cone, plant or any component of the obstacle
- Incurt or break of gait at walk or trot for two strides or less
- Both front or hind feet in a single stride space at a walk or trot
- Dropping over or falling to step into required space
- Incurt number of strides, if specified
- One to two steps on dirtmound or ground to except shifting to balance
- Subl pole at lope
- Over-trotted (per manure)
- Out of frame (per manure)
- Wrong lead or out of lead for less than 2 strides

**3 Point Penalties:**

- Wrong lead or out of lead for more than 2 strides
- Draped rein
- Break of gait at Lope
- Break of gait at Walk or trot for more than two (2) strides
- 2-4 steps on dirtmound or ground tie
- Trotting more than 3 strides in a lope departure or exiting a rollback into a lope

- Knocking down or over, or severely disturbing an obstacle
- Stepping out of or falling off of an obstacle with one foot
- Missing or evading part of a lightobstacle that is part of a series of obstacles with one foot

**5 Point Penalties:**

- Spurring in front of cinch
- Blatant disobedience
- Use of either hand to mouth harassment
- Knocking over, stepping out of, or falling off of an obstacle with more than one foot
- Dropping an object required to be carried
- Hit or shed cumulative refusal
- Letting go of gait
- 5 or more steps on dirtmound or ground tie
- Missing or evading part of a lightobstacle that is part of a series of an obstacle with more than one foot

- Breaking pattern
- Repeated blatant disobedience
- Use of two hands (except in snaffle bit or hackamons)
- More than one finger between split reins or any fingers between normal reins (except two reins)

**00:**

- Lameness
- Abuse
- Single equipment
- Cheeked or miscounted
- Leaving arena before pattern is complete
- Improper western attire
- Fall of horse/rider
