- Error / Penalty 5**
 • Step Out or jump off with two or more feet (After entering) • Drop object • 1st refusal or evade • Dropping Gate • Blatant disobedience • 2nd refusal or evade
 • Instill fear or praise • Holding saddle horn

Disqualification

- Error / Penalty 0**
 • Work obstacle wrong • Wrong line of travel • Working outside course boundary • 3rd refusal or evade
 • Dropping the rope gate and not picking it up • Fail to complete obstacle • Excessively or repeatedly touching horse • Overturns of more than 1/4 turn
 No attempt to perform obstacle • Performing obstacles out of order • In-hand: Horse gets loose or leading on the wrong side
